

## OFFICIAL RULES - The General Electric Credit Union FC Cincinnati Giveaway

**Sweepstakes Entry Period**: The General Electric Credit Union ("GECU" or the "Sponsor) FC Cincinnati Giveaway (the "Sweepstakes"), begins on February 19, 2025, at 12:00:00 AM Eastern Time ("ET") and ends on February 23, 2025, at 11:59 PM ET (the "Sweepstakes Entry Period"). Any material submitted outside the Sweepstakes Entry Period will not be eligible for an entry.

**Eligibility**: The Sweepstakes is open to legal residents of the United States, who are 18 or older. Void outside of the United States, where prohibited by law, and subject to all applicable federal, state, and local laws. GECU team members and their immediate family members are not eligible to participate or win. Participation in the Sweepstakes is limited to one (1) entry per person. **How to Enter**: Eligible parties who leave a comment on the Facebook or Instagram post for this giveaway AND fill out the provided contact form will be given one (1) entry to the Sweepstakes.

**Random Drawing**: The winner will be selected by GECU team members, held on or about February 24, 2025, from all the eligible entries received during the Sweepstakes Entry Period. Odds of winning depend on the number of eligible entries received.

**Prize**: There will be one (1) prize awarded. The selected winner will receive one (1) \$50 e-gift card to FC Cincinnati's online shop. The prize is not transferrable. The winner is solely responsible for reporting and paying all applicable state and federal taxes.

Winner Notification & Verification: The winner will be notified through the email address they provide in the linked form listed in the caption of the giveaway post. You do not need to be present for the drawing to win, however it is the responsibility of the entrant to fill out the contact form to be selected as a winner. If the winner is disqualified, GECU reserves the right to conduct another drawing to determine an alternative winner or not to award the prize, in its sole discretion. If the prize is unclaimed, the prize may be forfeited and awarded to an alternate winner. GECU is not responsible for lost or misdirected entries, removed entries, or failure to receive entry information on account of technical problems, actions by a third party, or traffic congestion on the Internet or at any website or any combination thereof. Entries not submitted in the manner described above will not be considered and may be deleted.
